Barriers to future attainment for pupils eligible for the Pupil Premium Grant (PPG)

As a school, we recognise that these barriers are often experienced by pupils not eligible for the PPG and that children who are eligible for the PPG often do not have these life experiences.

A	Many pupils come from homes less able to support and develop positive learning models at an early age and therefore enter schooling at an academic disadvantage to their peers. This can also manifest itself in a lack of expectation within the family that a child can achieve academically to their full potential.
	Desired outcomes: That attainment at the end of KS1 and KS2 phases is at nationally expected levels or better.
В	Many pupils eligible for the PPG have experienced trauma and have less well developed social and emotional skills. This makes them
	unprepared for learning, reduces the opportunity for successful friendships and playtimes often leading to disruptive behaviour.
	Desired outcomes: Personalised provision tackles pupils with gaps in their learning, low levels of engagement and confidence and improves
	progress and attainment. Pupils are able to access learning because their wellbeing and emotional needs are being met.
С	Many pupils do not have access to resources and the wider experiences needed for a rounded education.
	Desired outcomes: Pupils have access to extended provision, resources, first hand experiences and wider opportunities.
D	Attendance rates, for some pupils, are below target and reduce their school hours.
